RANDOM DRAWINGS DETAILS: Random drawings will be held according to the dates listed above in the Random Drawing Schedule from all eligible Entries received by RBFCU at RBFCU, P.O. Box 2097, Universal City, TX 78148-2097. Any Entries sent to any other address will be ineligible and void. Decisions of the sponsor is final on all matters relating to this Sweepstakes. Entries from joint accounts, the individual listed as the primary account holder will be considered the entrant. For automatic Entries from joint borrowers under the Mortgage, Consumer Loans and Credit Card categories, the individual listed as the primary borrower will be considered the entrant.
